

WestEd End User License Agreement for Making Sense of SCIENCE

We have chosen to make these materials easily available as a digital download for the benefit of teachers and their students. In exchange, we ask you to honor the hard work that goes into developing them.

Please read this End User License Agreement (this "Agreement") carefully. By downloading, printing, copying, and/or using any of the files or content from the Making Sense of SCIENCE Digital Resources ("Materials"), You or the entity You represent (collectively, "You") acknowledge and agree that: (1) You have read this Agreement; (2) You understand it; and (3) You are bound by the terms of this Agreement, as this Agreement is enforceable like any written contract signed by You. If You do not agree to the foregoing, WestEd does not authorize You to print, copy, and/or use the Materials.

- 1. Limited License.** Subject to the terms and conditions of this Agreement, WestEd ("WestEd") hereby grants to You a non-exclusive, non-transferable, and royalty-free limited license to print, and use the Materials for the sole purpose of teacher professional development and/or course implementation at the entity You represent. The Materials are available only to users who have been granted user IDs and passwords ("Registered Users"). If You are a Registered User, You agree to keep up to date any information about yourself that You have provided to WestEd. A waiver of any default is not a waiver of any subsequent default. This Agreement is binding upon and is for the benefit of the respective successors and assigns of the parties hereto. The parties acknowledge and agree that a material breach of this Agreement, and any action adversely affecting WestEd's proprietary rights, would cause irreparable harm to WestEd for which a remedy at law would be inadequate and that WestEd shall be entitled to injunctive relief in addition to any remedies it may have hereunder or at law.
